

# **HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT**

## **Section I, Definition of Terms**

For the purposes of this document, the following terms shall be used:

- The LAN Party, also referred to as a “computer gaming event” or “Recoil” is officially known as

Recoil LAN.

- The location is the physical location of Recoil, held at:

Crowne Plaza (Fort Couch Road).

- The website is the official Internet location for information for attendees regarding Recoil.

## **Section II**

I hereby acknowledge that I desire to participate in the computer gaming event which is entitled and defined in section I as “Recoil LAN” at “Crowne Plaza”. I also acknowledge that my decision to participate in Recoil is totally voluntary and is solely for the purpose of my pursuit of recreational activities that I enjoy.

I agree that I am fully aware of the risks and hazards inherent in entering the premises and/or in participating in Recoil and hereby elect to voluntarily enter upon said premises, knowing the present condition and knowing that said condition may become more hazardous and dangerous.

I, the undersigned, hereby assume all risk of illness or injury in Recoil in which I voluntarily participate.

For and in consideration of permission to participate in Recoil, I hereby irrevocably and forever release, discharge, waive and hold harmless Recoil and its officers, directors, employees, sponsors and agents (collectively referred to as “the hosts”) from any and all claims, losses, causes of action and liabilities of any kind (including attorneys’ fees) arising out of or relating in any way to Recoil. I voluntarily waive any claims that I might have against the hosts, and I understand and agree that the hosts assume no responsibility or liability for any injury to persons or property (including property that is lost, stolen or damaged), that may occur during Recoil.

I agree that I have read and will follow all official rules which are posted on the website and at Recoil. I further agree that during Recoil I shall conduct myself in an appropriate fashion and I shall not behave poorly by violating rules, performing harmful acts, using profanity, obscenity or any otherwise objectionable conduct towards any person or property involved with Recoil. I recognize and understand that the hosts reserve the right to require cessation of any such activity and the hosts, in their sole discretion, may require my removal from Recoil, without any refund of any kind.

I agree that I am at least 18 years of age, or that if I am not 18 years of age, that the undersigned parent or guardian has executed this Hold Harmless and Assumption of Risk Agreement on my behalf. By signature of such parent or guardian, the parent or guardian is binding the participant to all the terms of this Hold Harmless and Assumption of Risk Agreement.

I agree this instrument, in its entirety, is intended by me to be binding upon my heirs, executors, administrators, agents and/or assigns.

# **HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT**

## **Section III**

This section is only necessary if this agreement is being executed on the behalf of a minor child, a person under the age of 18, and should be completed only by the parent or legal guardian of the minor child.

I am the parent or legal guardian of the minor child listed below. I hereby execute and enter into the Hold Harmless and Assumption of Risk Agreement on his or her behalf. I understand and agree that through participation in events held in connection with Recoil, including, without limitation, official tournaments, the event participants will likely play or be involved with M-Rated, or Mature-Rated, computer software games (with the M-Rating designating an industry rating of suggested play for individuals 17 years or older). I also acknowledge and agree that I have seen the game play involved with these games. Further, I understand that many individually owned computers brought to Recoil may display and/or contain content deemed not suitable for minors and that participants of Recoil can engage in informal competitions that may contain M-Rated games and/or other potentially objectionable material. I hereby provide my informed consent to my child's (or ward's) participation in such games at Recoil (including participation in games prior to, or following, Recoil), and to otherwise participate in Recoil.
